FIRST AID MEASURES

The product contains organic electrolyte. In case of electrolyte leakage from the battery, actions described below are required. Eye contact: Flush the eyes with plenty of clean water for at least 15 minutes immediately, without rubbing. TRANSPORT INFORMATION

During the transportation of a large amount of batteries by ship, trailer or railway, do not leave them in the places of high temperatures and do not allow them to be exposed to condensation.

During the transportation do not allow packages to be fallen down or damaged.

- C. Each package must be capable of withstanding a 1.2 m drop test in any orientation.
 - V. Damage to cells or batteries contained therein;
 - VI. Shifting of the contents so as to allow battery to battery (or cell to cell) contact;
 - VII. Releaser of contents.
- D. Quantity per package shall not exceed 10kgs.
- E. Each package containing more than four cells or more than two batteries installed in equipment must be complied with above item 1 and 2.
