- Use strong material for packaging boxes during their storage and transportation.
- Do not let water penetrate into packaging boxed during their storage and transportation.
- The batteries will be stored at room temperature.
- Do not store the battery in places of the high temperature exceeding 35°C or under direct sunlight or in front of a stove. Please also avoid the places of high humidity. Be sure not to expose the battery to condensation, water drop or not store it under frozen condition.
- Batteries are sure to be packed in such a way as to prevent short circuits under conditions normally encountered in transport.

DISPOSAL CONSIDERATIONS

When the battery is worn out, dispose of it under the ordinance of each local government or the low issued by relating government. Disposal of worn out battery may be subjected to Collection and Recycling Regulation.

TRANSPORT INFORMATION

During the transportation of a large amount of batteries by ship, trailer or railway, do not leave them in the places of high temperatures and do not allow them to be exposed to condensation.

During the transportation do not allow packages to be fallen down or damaged.

Lithium ion or Lithium polymer batteries identified by manufacturer as being defective for safety reasons, or that have been damaged that have the potential of producing a dangerous evolution of heat, fire or short circuit are forbidden for transport(e.g. those being returned to the manufacturer for safety reasons).

- B. Each package must be labeled with a lithium battery handling label. The width 120mm X 110mm sized lithium battery handling label must be labeled onto the side of a package without bending it.
- C. Each package must be capable of withstanding a 1.2 m drop test in any orientation.
 - V. Damage to cells or batteries contained therein;
 - VI. Shifting of the contents so as to allow battery to battery (or cell to cell) contact;
 - VII. Releaser of contents.
- D. Quantity per package shall not exceed 10kgs.
- E. Each package containing more than four cells or more than two batteries installed in equipment must be complied with above item 1 and 2.
