#### FIRST AID MEASURES

The product contains organic electrolyte. In case of electrolyte leakage from the battery, actions described below are required. Eye contact: Flush the eyes with plenty of clean water for at least 15 minutes immediately, without rubbing.   - VI. Shifting of the contents so as to allow battery to battery (or cell to cell) contact;
  - VII. Releaser of contents.
- D. Quantity per package shall not exceed 10kgs.
- E. Each package containing more than four cells or more than two batteries installed in equipment must be complied with above item 1 and 2.
