# FIRST AID MEASURES

The product contains organic electrolyte. In case of electrolyte leakage from the battery, actions described below are required. Eye contact: Flush the eyes with plenty of clean water for at least 15 minutes immediately, without rubbing. - Do not let water penetrate into packaging boxed during their storage and transportation.
- The batteries will be stored at room temperature.
- Do not store the battery in places of the high temperature exceeding 35°C or under direct sunlight or in front of a stove.
   Please also avoid the places of high humidity. Be sure not to expose the battery to condensation, water drop or not store it under frozen condition.

# **TRANSPORT INFORMATION**

During the transportation of a large amount of batteries by ship, trailer or railway, do not leave them in the places of high temperatures and do not allow them to be exposed to condensation.

During the transportation do not allow packages to be fallen down or damaged.

Lithium ion or Lithium polymer batteries identified by manufacturer as being defective for safety reasons, or that have been damaged that have the potential of producing a dangerous evolution of heat, fire or short circuit are forbidden for transport(e.g. those being returned to the manufacturer for safety reasons).

- B. Each package must be labeled with a lithium battery handling label. The width 120mm X 110mm sized lithium battery handling label must be labeled onto the side of a package without bending it.
- C. Each package must be capable of withstanding a 1.2 m drop test in any orientation.
  - V. Damage to cells or batteries contained therein;
  - VI. Shifting of the contents so as to allow battery to battery (or cell to cell) contact;
  - VII. Releaser of contents.
- D. Quantity per package shall not exceed 10kgs.
- E. Each package containing more than four cells or more than two batteries installed in equipment must be complied with above item 1 and 2.
